

Temporary Restricted Area EKR744, Temporary Danger Area EKD745 and EKD746 and increase in vertical limits of existing Restricted Areas

Due to a military exercise, Temporary Restricted Area and Temporary Danger Areas over High Seas are established and the vertical limits of existing Restricted Areas will be increased.

All traffic is strongly advised to avoid flying in the Danger Areas.

IFR-Flight planning through the areas is not possible.

No traffic permitted in the Restricted Areas without prior permission from ATC.

The vertical limits of the following existing Restricted Areas will be increased:

EKR32 OKSBY, EKR33 VEJERS, EKR34 BORDRUP, EKR80 KALLESMÆRSK ØST and EKR81 KALLESMÆRSK VEST

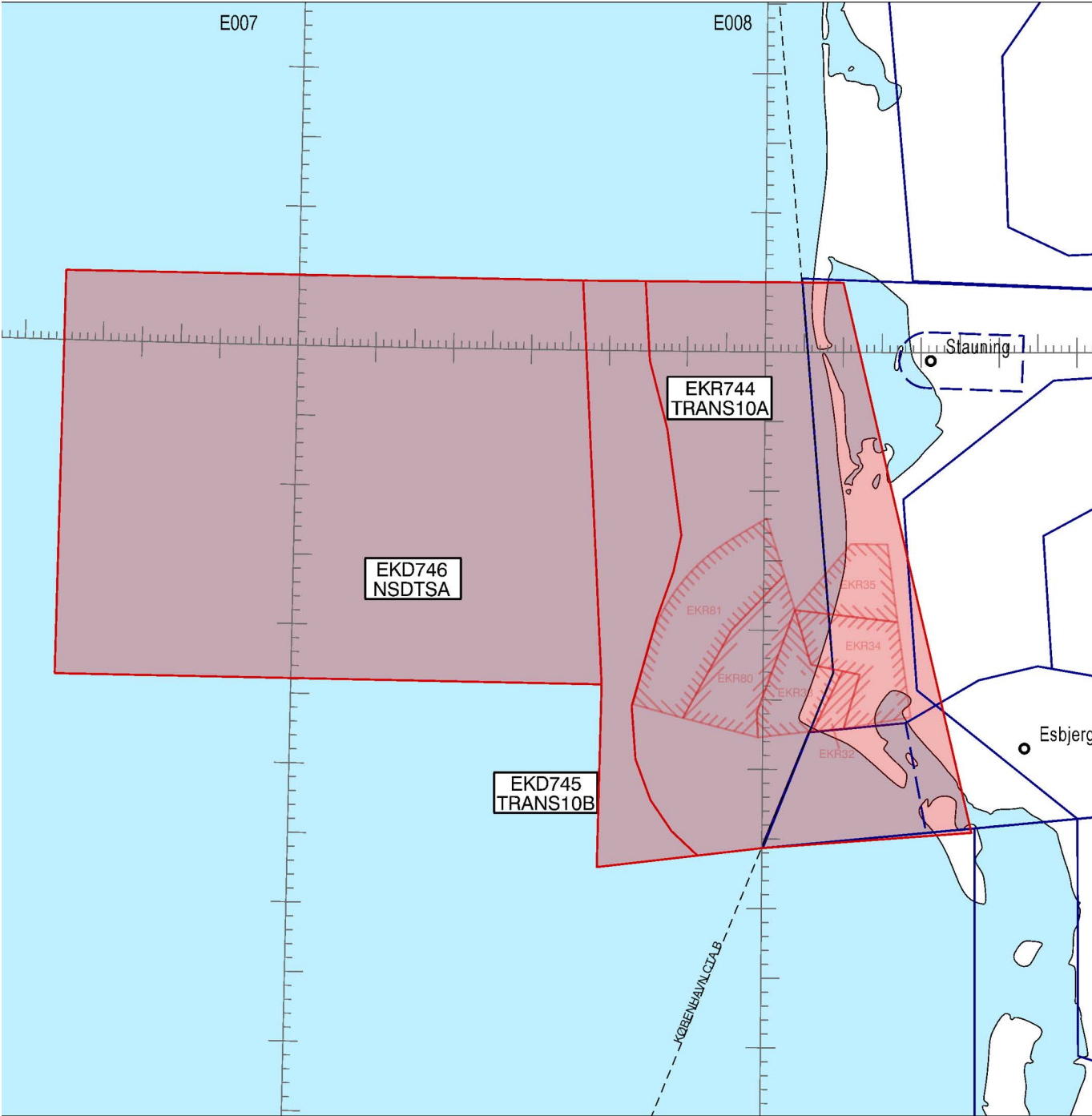
